

Guideline for Colorectal Screening, Surveillance & Recall and EGD & Colonoscopy Referral Form Questions and Answers for Providers

An updated Guideline for Colorectal Screening, Surveillance & Recall and an updated EGD (Esophagogastroduodenoscopy) & Colonoscopy Referral Form have been developed by the Colonoscopist and Primary Care Provider Working Groups for use in Northern Health.

- Q What are the major changes to the Guideline for Colorectal Screening, Surveillance & Recall?
 - **A -** The form has been revised to include guidance pertaining to which provider is most appropriate to provide follow up for asymptomatic patients.
- Q How can I access the newly updated Guideline for Colorectal Screening, Surveillance & Recall?
 - **A -** A link to the new guideline is provided through Community MOIS or is accessible through the Northern Health Physicians website under 'News' https://physicians.northernhealth.ca
- Q What are the major changes to the EGD (Esophagogastroduodenoscopy) & Colonoscopy Referral Form?
 - **A -** The form has been revised to add BMI and section 4 on page 1 was adjusted to accommodate more space in the clinical history section for documentation.
- Q Who is required to complete the *EGD* (Esophagogastroduodenoscopy) & Colonoscopy Referral Form?
 - **A -** We are asking that this form be completed by all NH Primary Care Providers and Internal Medicine Specialists or their office staff when referring a patient to an endoscopist for an EGD or Colonoscopy.
- Q Who and where should this referral form be forwarded to once it is completed?
 - A The completed form is forwarded directly **as per your normal process** to the endoscopist office of your choice.
- Q Is the newly revised form available to Primary Care Providers using Community MOIS within NH?
 - **A -** The newly developed PDF fillable form is available in Community MOIS and all supported MOIS instances in NH can be uploaded through the Forms Exchange as per your normal processes.
- Q How will the revised referral form be made available to Primary Care Providers who have other versions of Electronic Medical Records?
 - **A -** The newly developed PDF fillable form will be available for your vendors to modify and upload to your existing system as per your normal process. Contact Colleen Bowers at <u>colleen.bowers@northernhealth.ca</u> for assistance with this process.
