



URGENT: Drug Recall

The Issue: Baxter has issued a voluntary, precautionary recall for several of their pre-mixed drug products and IV fluids. This recall is due to a potential for the bags to leak at the connection site during spiking or dislodgement of the tube membrane when removing the spike. Affected products were put on the market from January 11 to July 12, 2023.

- NH Pharmacy will provide recommendations below for recalled stock provided by pharmacy. When alternative products are not possible, staff should be aware of the potential for leakage and report leakage incidents via PSLS
- Provincial Health Services Authority (**PHSA**) will be evaluating the recalled IV fluids (Stores items) and providing recommendations on further notice

Practice Implications:

- Clinicians should be aware of the full list of recalled lots and products (see page 2 to 4) and any available mitigation strategies provided below
- Nursing/pharmacy/prescribers <u>must exercise caution</u> if utilizing any of the recalled IV fluid bags (e.g. NS, D5W, LR) to mix hazardous medications on the ward. This is due to the potential for leakage/spillage and further exposure.
