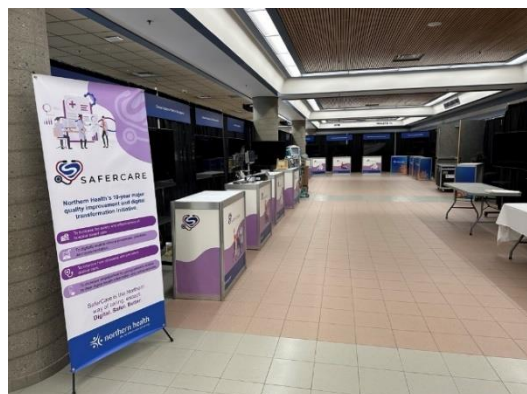

New generative Artificial Intelligence tool now available for all NH staff and medical staff

Generative Artificial Intelligence (generative AI or GenAI) is becoming more widely used in health care and other industries, and Northern Health recognizes the benefits of this innovative technology and how it can help save time for health care workers. NH is implementing generative AI tools and policies to take advantage of this technology.



As of June 13, [Microsoft Copilot for Web](#), a web-based GenAI tool, was launched to offer the benefits of GenAI while protecting the privacy and security of the NH workforce and patients.
