### Latest news: Haida Gwaii sites pushed out

Ongoing consultations with the Ministry of Health have created enough uncertainty that the SaferCare Steering Committee has made the difficult decision to push out the first go live dates for Haida Gwaii. Haida Gwaii Hospital and Health Centre – Xaayda Gwaay Ngaaysdll Naay (Daajing Giids) and the Northern Haida Gwaii Hospital and Health Centre (Masset) were originally scheduled to go live in October 2025. Pushing out the go lives for both these sites will ensure all critical components are in place for a safe and successful implementation. This means the subsequent golives planned for Fort St. James and Terrace will

also be pushed out. The SaferCare Steering Committee understands this decision may be disappointing and remains committed to a successful implementation and supporting teams through this transition. Updated timelines will be communicated once more information is available.

# Carbon copy (CC) in Cerner PowerChart available to all providers

In addition to <u>build work</u> and <u>go live preparation</u>, SaferCare team members have been working on a <u>Carbon Copy (CC) functionality in Cerner PowerChart</u>. This functionality allows providers to specify recipients and direct copies of documents to them. It includes a signature block that displays the name of the document author and any carbon copies. This feature is available to all providers. It is the equivalent to "Copy to" or "CC" in an email context. While automated distribution rules for some document types are already in place, the ability to directly specify document recipients helps clarify document distribution and enhances the clinical documentation process overall.

# Carbon copy improves provider communication and collaboration

The implementation of the CC functionality is beneficial for providers as it addresses the urgent need for self-authored documentation. It enables physicians to copy other providers and also provides a mechanism to add and copy new providers outside of the health region in the rare case they are not listed in the Cerner provider lookup table.









This improves communication and collaboration by directing documents to the full list of intended recipients in an easy workflow for the documenting physician.

"[It] might seem like a small thing, but having clear and concise communication about patient information being sent from hospital to community systems means that patients get better care in the community. This is also essential for the upcoming go live of SaferCare, as more in-hospital documentation will happen directly in Cerner." – Dr. Carl Severson.

#### Carbon copy paves the way for comprehensive digital clinical documentation

The carbon copy functionality is integral to SaferCare, as it facilitates the transition to comprehensive in-hospital digital clinical documentation using the Cerner electronic health record (EHR) system. By enabling digital clinical documentation, carbon copy significantly enhances the overall documentation process within NH acute care facilities. This improvement not only streamlines clinical workflows but also boosts the efficiency of health care providers, contributing to the broader goals of SaferCare to increase patient safety and the effectiveness of care.
